Pre-EUG Empower User Workshop:

This two-day workshop is designed for an Empower end user with less emphasis on the Administrator functions. Whether you're new to the platform or looking to deepen your understanding as an end user, this hands-on session offers valuable insights and practical skills. Participants will explore the following topics:

- **Empower Basics**: Navigate Empower's tripane layout, menus, toolbar items, and utilize Standard Charts, Reports, Views, Dashboards, and Filters.
- Administrator Fundamentals: Gain a basic overview of administrative functionalities, including the data loading process, supported file types, and Admin Menu options.
- **Schedule Analysis**: Understand schedule integration in Empower and explore features such as schedule-specific charts/reports, Task Mode, and the NRO's Schedule Execution Metrics.
- **Earned Value Analysis**: Begin with basic analysis using the sort window for interactive filtering, progressing to advanced topics like inputting Variance Analysis write-ups and tracking action items.
- **Compliance Analysis**: Review DoD DECM and DOE Compliance metric results, and learn to drill down into flagged elements or activities using Empower's various tools.

Pre-EUG Empower Business Rhythm Workshop

A two-day case study workshop where attendees will gain practical hands-on experience navigating the complete monthly business rhythm using Empower. Participants will start with loading JSON files (IPMDAR and DOE CPP) and explore the platform's functionality through various user roles. The workshop will cover the following key topics:

- Interpreting JSON Files: Learn how to read and understand IPMDAR JSON and DOE CPP JSON files.
- Importing and Troubleshooting: Gain insights into importing JSON files and resolving common issues during the process.
- Contract Configuration: Configure contract options to enable compliance metrics, VAR narrative collection, and other key features.
- Recalculation Options: Understand recalculation settings and address common challenges.
- Data Validation and Quality: Ensure data integrity through effective validation techniques.
- User Management: Maintain and manage user accounts efficiently.
- Formal Reporting Generation: Generate EDI files, hard copy reports, and narratives.
- Customization: Create tailored views, dashboards, and more to meet unique needs.

Role-Based Navigation: Use Empower effectively as an earned value analyst, schedule analyst, control account manager, program manager, and compliance manager.

Eligibility: To attend the Business Rhythm Workshop, participants must already be proficient in Empower and/or have completed formal Empower training. This workshop is designed for Empower administrators and champions.

Note: All Empower workshops require a laptop computer with Wi-Fi capability.

Pre-EUG Humphreys & Associates OTB/OTS Implementation Course

This one day workshop provides an in-depth look at the formal reprogramming process or the establishment of a performance measurement baseline (PMB) in excess of the contract target cost also known as an Over Target Baseline (OTB). This may also include an Over Target Schedule (OTS) as the PMB will need to reflect a revised baseline schedule when the remaining contract work results in a date beyond the contract completion date. The implementation process from the decision to conduct formal reprogramming to the actual preparation of the OTB/OTS proposal is presented in detail. This includes alternatives that may be considered other than OTB/OTS implementation. Notifying the customer of the intent to implement an OTB/OTS and the subsequent review and approval process are also covered. This workshop also includes the requirements for reporting the reprogramming adjustments in the Integrated Program Management Report (IPMR) or Integrated Program Management and Data Analysis Report (IPMDAR). Subcontractors may also request implementation of an OTB/OTS from the prime contractor. How this situation should be managed and reported is also discussed.

Pre-EUG DOE/ASU IP2M METRR Facilitator Certification Workshop

Learn how to facilitate the implementation of the Integrated Project/Program Management (IP2M) Maturity and Environment Total Risk Rating (METRR) tool that is rapidly becoming a default mechanism to assess the effectiveness of Earned Value Management Systems (EVMS) execution. IP2M METRR's assessment of EVMS is statistically correlated with cost and schedule performance. The two-day workshop focuses on IP2M METRR implementation and content, including its environment and maturity components, and the interpersonal skills for effective facilitation sessions, such as the facilitator's role, how to facilitate a session, or team dynamics. Participants will gain and apply insights on facilitation, the IP2M METRR tool and its use, and will be exposed to experiences and insights from certified facilitators. Those seeking certification will complete a written exam at the end of the workshop.

Note, attendees seeking certification must meet the following objectives:

- 1. Before the workshop participation in an online session (the same session is tentatively scheduled for April 21 and April 23, from 8 AM to 1 PM MST)
- 2. During the workshop passing a written exam
- 3. After the workshop the submission of a case study on a facilitated session

Arizona State University will provide the certification upon completing the certification requirements (online session, two-day workshop with exam, and case study). Continuing Education Units (CEUs) will be offered for the online session and two-day workshop.
